8	<b>TESTICLES</b> . are the testicles of equal size with normal conformation and consistency for this age of bull?		
9	<b>DNA TESTING</b> . a sample of hair is to be pulled from the tail of the bull being inspected and inserted in the sample collector provided.

## DNA SAMPLING INSTRUCTIONS

1. Samples will be of the root ends from the animals tail hair
2. Obtain a clean comb free from hair and foreign matter.
3. Thoroughly wash and dry your hands.
4. Comb tail of animal to remove any foreign matter
5. Pull (DO NOT CUT) 20 to 30 tail hairs by wrapping hairs around the forefinger. Grasp hair close to animal's body to ensure the roots are obtained. Pull straight towards your body. If you look closely at the ends, you will see the root bulbs of the hair.
6. Place the tail hair with the root ends in a clean, sealable plastic pocket. **ROOT END MUST BE PROVIDED FOR TESTING TO BE POSSIBLE**
7. Complete and attach the following DNA PROFILING SAMPLE form.
  - a. Name of the Animal (Enter full UK ear tag number if the animal does not have a name)
  - b. Enter Date of Birth (DD/MM/YY)
  - c. Always enter the sires name
  - d. Is a parentage test required for this animal Y / N
    - i. Y = to confirm the sire and dam of this animal, DNA typing both parents must be carried out if not previously completed. Always use a separate, clearly labelled sample bag for each animal's hair.
    - ii. N = the DNA profile of this animal only will be tested
8. Send the sample and the attached DNA PROFILING SAMPLE form to: Animal Health Trust, Genetic Services, Lanwades Park, Kentford, Newmarket, Suffolk, CB8 7UU
9. If you are sampling multiple animals please thoroughly wash and dry your hands between each animal or alternatively please put on clean surgical gloves before each animal to prevent cross contamination.
